# OPEN ACCESS POLICY OF THE FZJ



# **CONDITIONS TO RECEIVE FUNDING THROUGH ZB**

Open Access Strategy of Forschungszentrum Jülich, effective as of January 1, 2023

**Corresponding author from FZJ** 



The corresponding author must be from FZJ. If there are several corresponding authors, the costs should ideally be shared between the institutions involved.

Cap at € 3,000 / OA article or € 5,000 / OA monograph



Gold open access costs are covered by the Central Library (ZB) when the corresponding author is from Forschungszentrum Jülich.

Restricted funding of hybrid OA publications



Hybrid OA APCs are only covered by the publication fund when the publication appears in a journal that is part of a transformative agreement concluded by ZB.

Diamond open access



The publication of the scientific findings of Forschungszentrum Jülich using the diamond open access model is explicitly encouraged.

- DOAJ is an independent database for open access journals from around the world
- In order to be listed, journals have to comply to quality standard
- The central library will fund APC for Gold OA journals listed in DOAJ with up to EUR 3,000

- Publisher's version immediately available for subscribers on publisher's website
- Possibly publication fees
- No additional charge
- Author transfers the copyright
- Permissions for re-use necessary



Only if part of existing agreement

#### **Hybrid Open Access**

- Publisher's version immediately available without restrictions on publisher's website
- Possibly publication fees
- Additional charge
- Author might transfer the copyright

#### **Green Open Access**

- Post-Print immediately or after embargo available without restrictions in repository
- Possibly publication fees
- No additional charge
- Author transfers the copyright, Permissions

#### **Gold Open Access**

- Publisher's version immediately available without restrictions on publisher's website
- Article Processing Charge
- No additional charge
- Author retains the copyright

## **INVOICING PROCESS**

- Paying OA fees is different from publisher to publisher
  - Sometimes you will get an invoice, sometimes the fees will be directly managed by Central Library staff
- When asked to submit payment information:
  - Ask for an invoice do not pay by credit card
  - Use your name as contact information
  - Use the address of the Forschungszentrum as billing address



# ADVICE/CURRENT VIEW ON AI AND LLMS IN PUBLICATIONS AND IN PUBLISHER POLICIES

#### AI Authorship

Large Language Models (LLMs), such as <u>ChatGPT</u>, do not currently satisfy our <u>authorship criteria</u>. Notably an attribution of authorship carries with it accountability for the work, which cannot be effectively applied to LLMs Use of an LLM should be properly documented in the Methods section (and if a Methods section is not available, in a suitable alternative part) of the manuscript.

#### Generative AI Images

The fast moving area of generative AI image creation has resulted in novel legal copyright and research integrity issues. As publishers, we strictly follow existing copyright law and best practices regarding publication ethics. While legal issues relating to AI-generated images and videos remain broadly unresolved, Springer Nature journals are unable to permit its use for publication.

Exceptions are images/art obtained from agencies that we have contractual relationships with that have created images in a legally acceptable manner. Other exceptions to this policy include images and video that are directly referenced in a piece that is specifically about AI and will be reviewed on a case-by-case basis.



When a subject matter expert is invited to participate in the review process, the material/manuscript must be treated as confidential. Reviewers should not upload the material/manuscript or any part thereof into a generative AI tool as this may violate Elsevier's and/or the authors' confidentiality and proprietary rights and, where the material/manuscript contains personally identifiable information, may breach data privacy rights.

This confidentiality requirement extends to all communication about the material/manuscript including any reviewer questionnaires, reports, or correspondence, as these may contain confidential information about the material/manuscript, Elsevier and/or the authors. For this reason, reviewers should not upload their communications or any related material into an AI tool, even if it is just for the purpose of improving language and readability.

Elsevier abides by the highest standards of integrity in the review process which implies responsibilities that can only be attributed to humans. Generative AI or AI-assisted technologies should not be used by reviewers to assist in the review of the material/manuscript as the critical thinking and original assessment needed for review is outside of the scope of this technology and there is a risk that the technology will generate incorrect, incomplete or biased conclusions. The reviewer is responsible and accountable for the content of the review.

Elsevier's AI policy for book authors states that authors are allowed to use generative AI and AI-assisted technologie in the writing process before submission, but only to improve the language and readability of their work and with the appropriate disclosure, as per our instructions in Elsevier's Guide for Authors.


